MINUTES OF THE PARISH COUNCIL MEETING

VIRTUAL MEETING HELD ON THURSDAY 11TH FEBRUARY 2021 at 7.30 p.m.

PRESENT

Councillors: T Whiskard (Vice Chairman), G Barber, M Bhatia, M Eardley, J Flitcroft, D Fosbrook, B Griffiths, J Sinclair Smith and M Horrox. Cllr Whiskard chaired the meeting in the absence of the Chairman.

Also present: Cheshire East Ward Councillor Andrew Gregory, PCSO Jim Newns, one Member of the Public (MOP) and the Sutton Parish Clerk.

- **THE COUNCIL RESOLVED** to **approve** apologies for absence received from Councillors A Waller (Chairman), R Chamberlain and E Jones.
- 23/21 DISPENSATIONS AND DECLARATIONS OF INTEREST None declared.
- **24/21 THE COUNCIL RESOLVED** to **approve** the Minutes of the Meeting dated 14th January 2021 which were confirmed as a true record with one minor amendment to 5/21.
- **PUBLIC PARTICIPATION THE COUNCIL RESOLVED** to **receive** Questions and concerns from Members of the Public (MOP): The MOP had no questions or concerns to put to Members.

MEMBERS REPORTS

26/21 THE COUNCIL RESOLVED to receive report from the Cheshire East Ward Member:

- There are ongoing issues within Macclesfield Forest. Discussions have taken place with United Utilities (UU) and they are interested in how they can most effectively communicate with local residents and engage with a wider group of residents. Members suggested regular presentation/update from United Utilities to open a dialogue.
- There continues to be an ongoing issue with mountain bikers using the trails and causing some concern for walkers.
- Langley pond local residents have commissioned a planning consultant to help them with this matter. No news yet.
- Nothing to report regarding the Lyme Green settlement proposed planning application.
- Marker posts there are reservations from Cheshire East (CEC) about putting up posts. Noted there is not a great deal of support from CEC on this.
- Reported there was a full Council meeting to discuss the budget and there are concerns that there is less money for Highways.

It was noted that MOPs are asking Members what is happening in the forest and that there is a need for UU to communicate to wider number of people.

- 27/21 THE COUNCIL RESOLVED to receive report from the Macclesfield Neighbourhood Policing Team (PCSO J Newns):
- 12/1 Suspicious vehicle reported (blue van).
- Fly tipping reported this is a problematic theme.
- 13/1 Theft of motorhome Judy Lane retrieved in Bollington area.
- 14/1 van number plates taken.
- Reported COVID breach.
- Theft of magazine in Sutton Post Office retrieved.
- Macclesfield golf course reported issues with ASB youths messing with golf buggies.
- 3/2 men seen looking down Symondley Road and Walker Lane. Same men seen on CCTV in Bollington. Nothing taken but shed entered on Walker Lane. Residents asked to remain vigilant.
- Ongoing issues in Macclesfield Forest there to support Civil Enforcement Officers at the weekend.

Reported fly tipping Gore End Lane - fridge freezers dumped.

Funding – Informed the available funding reported in previous meeting is for tackling anti-social behaviour.

28/21 THE COUNCIL RESOLVED to **receive** report on Macclesfield Forest & Wildboardough Working Group Meeting.

Minutes forwarded to Members largely covered UU updating on extra signage, traffic signs etc. Discussed double yellow lines but, with mixed views and reservation from Highways about the effectiveness in the forest. Matter would also have to go out for consultation.

HIGHWAYS MATTERS

29/21 THE COUNCIL RESOLVED to agree to report that following highways issues:

- Column 70 not working reported to contractor.
- Hole House Lane, Langley did not get gritted. This is main access to reservoir and car park and access to
 advertised car park. Used to be a grit box in the past but disappeared and has not been put back. Grit boxes
 still empty.
- Ridge Hill Road hedges still not cut must be cut before birds start nesting. CEC must cut and charge the
 owner if no date has been set.
- Leek Old Road surface is collapsing at the edge just past the reservoir going uphill towards Leek.
- Walker Lane surface around manhole at the crossroads of Walker Lane, Bullocks Lane and Robin Lane deteriorating.

MATTERS FOR CONSIDERATION BY THE COUNCIL

- 30/21 THE COUNCIL RESOLVED to agree the continuation of virtual meetings.
- 31/21 THE COUNCIL RESOLVED to consider whether there is a role for the Parish Council in raising awareness with visitors who are using the countryside/forest for the first time. This matter came out of quiet lanes and the increase in people coming into the forest. Members discussed communicating effectively and also promoting the country code. The electronic signs request that the public keep to country code however, some visitors may not know the code. Suggested talking with UU regarding making printed copies of the code available including on noticeboards. Noted that Defra, Natural England NFU provide leaflets/posters that could be used. Suggested speaking with National Park about highlighting the Code in the car park and working with UU, Wardens and Canal and River Trust.
- 32/21 THE COUNCIL RESOLVED to agree to raise issues regarding the cutting of hedges at the back of Riverside Court and Main Road houses. Half the hedge has been ripped up which has left a massive open area. The verge on Church Lane has been dealt with and bench replaced.

ALLOTMENTS

- 33/21 THE COUNCIL RESOLVED to receive report from Allotment Group Meeting held on 3rd February 2021 and agreed to review allotment plots in April on site and it was noted that there are one or two tenants that will need chasing in the spring.
- **34/21 THE COUNCIL RESOLVED** to **agree** Tenancy Agreement for 2021/22.
- 35/21 THE COUNCIL RESOLVED to review Tenant's letter around sizing of Allotment Plots 5A and 6A and noted his complaint about his allotment sizes and tenancy rate. It was therefore agreed to arrange to remeasure the allotments however, the allotments were transferred in good faith from Cheshire East Council and the Parish Council would be unable to adjust the allotment plots but would adjust his payments when the next rents are due.

PLAYING FIELDS - ROBIN LANE

- 36/21 THE COUNCIL RESOLVED to receive report from Park 4all @Lyme Green:
 - 1. Funding has now been secured to purchase the accessible play equipment for the children's play area. The equipment is being purchased from Kompan which has given a lead in time of 8 12 weeks. It is, therefore, hoped that the play area will be installed in spring.
 - 2. The Friendship Benches, one has now been installed and a second friendship bench will be installed near to the park entrance once the base has been laid.

- 3. Sensory garden, there have been some problems following the heavy rainfall with the drainage around this area. Ansa is addressing these problems and has been in contact with residents in Minor Avenue who have been affected.
- 4. Planting in the raised beds and Sensory Garden will be done in the spring.
- 5. The community library has been constructed by a volunteer and will be installed once the base is laid.
- 37/21 THE COUNCIL RESOLVED to receive update from Ansa regarding flooding Lyme Green Park. Ansa are addressing the problem with the sensory garden and are in discussion with the Canal and River Trust and residents regarding the drainage.
