PRESENT

Also present: Cheshire East Ward Councillor Andrew Gregory, one Member of the Public (MOP) and the Sutton Parish Clerk.


- **49/21 THE COUNCIL RESOLVED** to **approve** apologies for absence received from Councillor R Chamberlain and PCSO Jim Newns.
- 50/21 DISPENSATIONS AND DECLARATIONS OF INTEREST

 Cllrs G Barber and J Sinclair Smith declared interests in Resolution 70/21 as members of the Parochial Church Council (PCC).
- **51/21 THE COUNCIL RESOLVED** to **approve** the Minutes of the Meeting dated 11th February 2021 which were confirmed as a true record.
- **52/21 PUBLIC PARTICIPATION THE COUNCIL RESOLVED** to **receive** Questions and concerns from Members of the Public (MOP):

MOP spoke regarding application for the Hanging Gate (planning application 21/0881M) giving Members an overview of the application and answering questions they had about the application.

MEMBERS REPORTS

- 53/21 THE COUNCIL RESOLVED to receive report from the Cheshire East Ward Member:
 - The Gamekeeper the planning application has been called in and he understands from the Planning Officer it has been refused. It is likely the owner will appeal. Cllr Gregory agreed to investigate the possibility of acquiring as a community pub and report back at the April meeting.
 - Langley pool call in notice accepted for 7th April. Arranging a meeting on 29th March with other residents and Parish Council to discuss. Members discussed whether a method statement, risk assessment had taken place or whether the pool was inspected by specialist reservoir engineer and if not, should it have an independent inspection.
 - Gas works there are a lot of issues with traffic on Main Road. Langley Councillor reported that she is in regular conversation with Cadent and has spoken with them about maintaining traffic flow on Main Road.
 - Lyme Green Settlement application confirmation from the agent that this has been lodged with Planning Authority.
 - Macclesfield Forest the working group met yesterday and will circulate the Minutes. Progress is being
 made in a number of areas including the traffic survey (paid for by United Utilities (UU)), signs will be
 going back up soon for Easter and United Utilities are looking into paying for new repeater signs. The UU
 Land Agent would like to improve the exchange of information with the Parish Council.
- **THE COUNCIL RESOLVED** to **receive** report from the Macclesfield Neighbourhood Policing Team (PCSO J Newns):
 - Reports of dog biting animals and people. Dealt with accordingly.
 - Speeding on Byrons Lane Trucam enforcement. Still awaiting, for confirmation of TRUCAM site on Hall Lane.
 - School Parking Patrols and school engagement at Hollinhey Primary School ongoing.
 - Anti-social behaviour Macclesfield Golf Club patrols and reassurance given.
 - Macclesfield Forest ongoing patrols supporting the local community and dealing with issues as they arise.
- **THE COUNCIL RESOLVED** to **receive** report on Macclesfield Forest & Wildboarclough Working Group Meeting.



The meeting was brought forward because of the relaxation of COVID restrictions and the potential increase in public due to bank holidays. Discussed traffic survey, signs, plans to keep mountain bikes on specific paths. They are pressing to make sure enforcement available, including UU security officers, around and over bank holiday weekends. Concern over displacement of cars parking in Langley.

Members discussed raising awareness and educating the public in the country code and **agreed** that this needed raising with the working group.

It was raised that the Futures Group could report regular to the Parish Council.

Agreed to send a formal invite to the UU Land Agent to address meeting.

The installation of the play area almost brings to completion the original plan for the park as drawn up from residents' responses to the questionnaire circulated to every household in Lyme Green in November 2017.

Ansa are in contact with the Canal and Rivers Trust but, have not as yet looked into their suggested charges.
