- 211/21 THE COUNCIL RESOLVED to receive Dispensations and Declarations of Interest from Cllrs Sinclair Smith and Barber with respect to Resolution 217/21 (as members of the Parochial Church Council (PCC)).

## **MEMBERS REPORTS**


- 214/21 THE COUNCIL RESOLVED to receive report from the Cheshire East Ward Member (Appendix 1).
- 215/21 THE COUNCIL RESOLVED to receive report from Macclesfield Neighbourhood Policing Team (Appendix 2) and agreed to send letter of thanks and appreciation.
- **216/21 THE COUNCIL RESOLVED** to **receive** report from Macclesfield Forest & Wildboardough Working Group, to **note** minutes of meeting and **agree** action.
  - Traffic surveys have been completed however, they are still analysing the data and have not released the figures.
  - It was noted that Christmas trees will no longer be for sale to MOPs however, Members **agreed** to enquire whether any signage will be up informing the public of this.
  - Councillor reported that she had said that communication with the Parish Council and the Community was not good and offered a page on the Parish website to keep the public updated.
  - Parking signage still ongoing.
  - There has been a considerable reduction in traffic into the forest.

# 217/21 THE COUNCIL RESOLVED to review report from church yard working group.

The first meeting for the group was held on 9<sup>th</sup> November and included the PCC, Parish Council representatives and Community Groups. It is early days however the PCC have agreed to proceed with a public consultation.

#### HIGHWAYS MATTERS

- 218/21 THE COUNCIL RESOLVED to receive reports on highways issues and consider projects to put forward for pilot:
  - Weeds and saplings growing on paving at bottom of Clarke Lane and up towards Redhouses along Bottoms Reservoir. Three sapling roots starting to push up pavement and need cutting down.
  - White lines at the bottom of Jarman have worn away.
  - Grit concerned that all grit bins have not been filled and potential for snow.
  - Large hole on pavement Church Lane (coming from Halls Lane) before bridge on left hand side.
  - Gully blocked on Red Lane massive holes were filled with tarmac by contractors however, they tarmacked over gully. Just past where Gritstone Trail crosses Red Lane.
  - Hedge trimming on Ridge Hill still not actioned.
  - Light by Brighton Cottages defective (flashing)
  - Footpath Stile going from Langley Road to Ridge Hill dog walkers struggling to get their dogs over the stile
  - Light not working on Gonville Avenue.



The following to be forwarded to Cllr Gregory and to enquire whether Councillor Projects are in addition to what Highways are currently contracted to deliver or just a mechanism for funding the current arrangements differently.

- a sign at the bottom of Bollinhead Lane at the junction of Whistons Lane for "unsuitable for heavy vehicles"
- Speed limit 30 mph signs on Langley Road there is no signage there.



THE COUNCIL RESOLVED to agree the following comments to send to Cheshire East Council: "Sutton Parish Council would object to this application for the following reasons:

- The one bedroomed units will not cater for the needs of a disabled person, who may require help from a sleep in carer or relative.
- There is not adequate space for wheelchair users i.e. turning space in the kitchen.
- The plans indicate that the bathroom will be a shower room, when a wet room would be required for a disabled person in a wheelchair.
- The parking space does not afford enough space for manoeuvring in and out of the space in safety.

In conclusion the proposals make it unsuitable for people using wheelchairs and therefore unfit for purpose. We therefore object to this application."

The current position of the stall was intended for parking, and we would suggest that the stall needs to be relocated and the parking reinstated if the stall is to be of a more permanent nature. The current application states that there are thirteen customer parking spaces however, this is not the case and includes parking on the road and staff parking and effectively means there are only six spaces for customers.



## Appendix 1 – Report from Ward Councillor Gregory

- 1. **CGR** He has posted a couple of videos on Facebook and prepared a second at the request of a Member of the Public to ensure that as many people as possible were aware of the proposed changes and should register their comments. He is aware that leaflets have also been distributed, but not aware of how well people have now reacted to the changes. He is going to make a few changes to his submission and will work on a final addition over the next weekend.
- 2. **Lyme Green Park** Unofficially he has been told that a final decision has been reached which will see the play equipment moved to where the library is presently located. He has asked that they brief the Park4all trustees and he hopes that the letter is sent to residents in the next week as it has become such a protected saga.
- 3. **Number 14 bus** The High Peak, the operator of the bus have reduced its services, citing shortage of drivers. A petition has been set up and a number of residents have been in touch with him. He has written to the High Peak to ask them why they appear unwilling to engage with their customers (as they have to date refused to meet with residents to consider alternative proposals) and he is waiting for an answer. He has also been in touch with the council, who took the stance that it was a matter for the operator, but then he then wrote again and asked them what he needed to do to make a business case for a subsidy for the bus service. The council responded to say that my enquiry raised a number of complicated points, so he is waiting for the response and will report back when he have more news on this.
- 4. **Planning** It is quiet on the planning front with no news on any of the pending applications in and around the Sutton Parish. The application in respect of the reserved matters on the Bovis development has now been lodged. It seemed to raise a number of detailed and complex points on the design which he did not feel qualified to comment on. He has decided to wait to see what views the planners would take towards the application which will come before the Committee in due course. He has called in the Fairways Garden Centre application and is waiting to hear on this. The intention with this one is tactical to see if the planners will let the members of the Northern Planning Committee hear the application.
- 5. **Planning -** Overall, there are a lot of people complaining about delays in applications being dealt with by CEC Planning Team. He was going to raise this at the November full council meeting but, that has been cancelled.
- 6. MFWG meeting The Ward Councillor was not able to attend the MFWG meeting, but he has noted the minutes.

# Appendix 2 - Report from PCSO

17/10/21 - Drink Driver arrested for drink driving Lyme Green after he collided with a hedge.

27/10/21 - Dog attack on sheep. Danes Farm Whiston Lane. Lady was interviewed at the station regarding the matter. She will pay vet costs and dog on bite register.

28/10/21 - ASB Currys Lyme Green business park. Youths identified and ASB letters sent home.

PCSO attended a Macclesfield Forest working group meeting Wednesday 3rd November and discussed policing issues with United Utilities and Cheshire East, Peak Parks and Langley Cllr. Namely parking, conservation/wildlife and joint operations to tackle ASB in the forest (Camp fires, camping littering, dog offences, mountain bikers and drug use were discussed.

He had words with the site manager Seddons about lorries taking inappropriate routes to the building site in Langley. He advised drivers to stick to agreed routes in and out as there have been a number of complaints. Any issues to let him know.

He continues to use TRUCAM on Byrons lane to tackle speeding and Hollinhey Primary school parking patrol.

Police Surgeries continue to be fruitful and forthcoming dates are Tuesday 23rd November Langley Village Hall 8-9pm, Sunday 28th November Lyme Green Park 2-3pm and Thursday 2nd December Ex Service Men Club Sutton 5-6pm.

He will be distributing Selecta DNA property marking kits in Lyme Green throughout November and December due to recent thefts.

# Appendix 3 - report from Park 4all @Lyme Green

- No decision regarding the relocation of the children's accessible play area has been received as yet from CEC/ANSA. The delay impacts on the installation of the final elements and completion of the park project. Until the play area relocation is completed ANSA are also reluctant to meet with Park 4all Trustees and Councillors to discuss the drainage situation.
- 2. The Christmas event is to be held on Friday 17th December. In addition to carols at the Christmas tree it is hoped there will be festive music and refreshments. A visit from Father Christmas has also been arranged. The timings are to be confirmed.
