
#### **HIGHWAYS MATTERS**

- Hall Lane opposite number 18 Hall Lane not working.
- Drains blocked on Hollin Lane. Cllr Eardley to provide details.
- Coming out of Gaw End lane, Lyme Green hedge overgrown.
- Ridge Hill hedge Judy Lane to Church House needs cutting.
- Langley Road hedge needs cutting.
- Leek Old Road hedge needs cutting on footpath side.



#### Appendix 1 – Report from Ward Councillor Gregory

Cllr Gregory attended the Wincle Parish meeting last Tuesday to hear the debate on the CGR proposals. There was not a large turnout, but those attending are determined to continue to gather support to register objections to the proposals.

Cllr Gregory agreed to produce a short video on the position.

He spoke to resident about gathering support around Lyme Green to oppose the proposals and this resident has been in contact with the Sutton Parish Clerk and resident is in the process of getting a leaflet prepared and circulated to urge residents to oppose the applications.

The issue of the location of the Lyme Green Park play equipment continues with many more emails from residents, many with different views on the position. He has spoken to Ansa who are planning a "challenge session" this week and they appear to be moving towards relocating the equipment close to the library.

He has been helping the garden centre to produce a revised set of plans and he notes have now been submitted to the council.

# Appendix 2 - policing issues for September/October

- Canal Boat at Gurnett Anti Social Behaviour etc. Many reports regarding the issues. Boat towed away by Canal and River Trust who we worked closely to resolve the issue.
- Theft of three expensive mountain bikes Robin Lane, Sutton. Proactive patrols to combat burglaries.
- Reports of swimming in Reservoir again.
- Church House Pub assault. Man arrested.
- Anti-social behaviour Macclesfield Golf Club car park during evenings namely littering and use of laughing gas Nitrous Oxide.

# Appendix 4 - Park 4all @Lyme Green

- 1. Robin Lane Park the decision on the relocation of the children's accessible play area is due to be taken in mid October. The major issue with the current location has been children standing on the top of the climbing tower and being able to see directly into people's gardens. In order to resolve this difficulty Park 4all @ Lyme Green CIO Trustees have put forward a compromise and suggested that the climbing tower be replaced with an agility trail and small slide. We understand that these would be installed when the play area is moved.
- 2. Christmas event previously (excluding Dec 2020 due to Covid restrictions) Park 4all have held a Christmas event near the Lyme Green Christmas Tree. We are hoping to hold an event on Friday 17th December including Christmas Carols, Brass band, Santa's Grotto, and Refreshments.

Sutton Parish Council have previously helped with the costs of printing the publicity fliers for the event to every household. Given that there are a significant number of people in Lyme Green who do not use mobile phones/computers it is important to distribute information to every household in addition to publicising on social media.

The Parish Council have also helped in the past, with a financial donation towards the cost of the Brass Band.

We would, therefore, respectfully request a commitment to assist with the costs i.e. £38 towards printing 310 A5 fliers and two laminated A4 posters also a £50 donation to the Brass Band.
