- 275/22 THE COUNCIL RESOLVED to receive and accept apologies for absence from Cllrs M Horrox, R Chamberlain, T Whiskard, Cheshire East Ward Councillor Andrew Gregory and PCSO J Newns. Cllr D Fosbrook was not present.
- 276/22 THE COUNCIL RESOLVED to receive Dispensations and Declarations of Interest: None declared.
- 277/22 THE COUNCIL RESOLVED to agree and sign the Minutes as a true record of the meeting dated 10th November 2022.
- 278/22 Public Participation THE COUNCIL RESOLVED to receive the following queries/questions from MOPs: There were no Members of the public present. The Chairman welcomed Cllr Eleanor Hall as our new Co-opted Councillor for the Sutton Lane Ends Ward.

- 279/22 THE COUNCIL RESOLVED to receive report from the Cheshire East Ward Member. See Appendix 1.
- 280/22 THE COUNCIL RESOLVED to receive report from Macclesfield Neighbourhood Policing Team. See Appendix 2. Reported that rover parked up on blocks on Walker Lane is legally parked.

 To enquire with PCSO if he has any recommendations for the Police and Crime Commissioners grant e.g. repeater signs, any other traffic calming, select DNA.
- 281/22 THE COUNCIL RESOLVED to receive report of the Climate Emergency Working Group. See Appendix 3.

HIGHWAYS MATTERS

282/22 THE COUNCIL RESOLVED to receive reports on highways issues:

- Walker Lane (near the poor house) road surface in poor condition with cars having to swerve to miss
 potholes.
- Road works being done on Jarman signage for division is very poor and directing traffic to Wincle with a
 poor return to Sutton. Members would like signage for diversion through the Seddons Estate. This problem
 is causing issues with businesses losing custom.
- 10 day closure on Fitzwilliam Avenue due Members are concerned that there are too many roads closed at the same time in this area please re-consider or re-assess.
- Cockhall Lane water running across road from the cricket club. This was a previous issue with diversion
 of water from cricket ground which is now freezing on the road. Report to Highways and write to cricket
 club, as there has been a number of complaints received from residents, and there is a significant amount of
 water freezing on the road.
- Sutton Reservoir recently reported, that where soil has been piled up this has caused water to divert on to the road which, is freezing and now dangerous.
- Hedge Langley Road still overgrown and dangerous to pedestrians. Clerk to ask contractor if he could trim back any particularly dangerous bits sticking out while Cheshire East arrange cutting with landowner.

- 284/22 THE COUNCIL RESOLVED to note that United Utilities have very kindly donated all the annual Christmas trees to the Parish of Sutton (Langley, Lyme Green, Sutton and Hollinhey School). Letter of thanks to be sent, recorded in grapevine and included on website. It was noted that the trees went up successfully however new lights maybe needed in the future.
- 285/22 THE COUNCIL RESOLVED to agree to support 20s Plenty campaign:
 - Calls on Cheshire East County Council to implement 20mph in Sutton Parish; and
 - Will write to Cheshire East County Council to request 20mph speed limits on streets throughout Cheshire

East where people live, work, shop, play or learn, with 30mph as the exception on those roads, where full consideration of the needs of vulnerable road users allows a higher limit.

286/22 THE COUNCIL RESOLVED to consider application for variation to amend the hours for the sale of alcohol to 09.00 to 00.00 each day for Sutton Hall, Bullocks Lane, Sutton, Macclesfield SK11 0HE and agreed that Members had no objection to commencing the sale of alcohol at 9 a.m. but would feel that the extension to the evening would be unneighbourly in terms of public and staff departing in the evening.

Appendix 1 - Report from the Cheshire East Ward Member

- 1. Hopefully the various issues with Brighton Crescent are now under review and at this stage there is no need for any further input from me as the new head of housing appears to have this under his wing.
- 2. I will be attending the Northern Planning meeting this Wednesday in respect of the two applications being Hawkshead Quarry and Kinderfields Farm.
- 3. My attempt to have the decision to remove peat from the Bovis site has been refused by the Council who say they will deal with this internally.
- 4. I have continued to keep in touch with the sub-committee of the Sutton Church "church yard group" and continue to offer support on their pending planning application.
- 5. I attended the Peak Park Authority meeting last Friday when their new management and landscape plans were approved. Please let me know if anyone wants any more information on these plans.

Additional report:

I attended the Northern Planning Committee. The position on the two applications is as follows.

Higher Kindersfields Farm - application refused on a unanimous basis.

Hawkshead Quarry - application granted (against officer recommendation to refuse) but, as happened last time as the officers contended that as the decision of the committee went against the Council's policy (which I disputed) the application now needs to be determined by the Strategic Planning Board. We will now await a date in the New Year for the application to be heard again by the SPB.
