Appendix 1 - Report from the Cheshire East Ward Member

I took a tour of the Sutton ward with representative from CEC Highways. This is to assist with spending some of the ward budget which has been allocated to me for minor works.

We drove though Langley and Andy noted that the majority of the minor lanes appeared to be in reasonable condition, he confirmed to me that all the roads previously on the gritting routes would remain for this winter. We did not identify any particular urgent road repairs needed in and around Sutton village and Langley, but please let me know if there is anything of particular concern which you think should be added to the list. Note that the works include minor road repairs, repainting white lines and replacement signage.

I have previously noted that revised plans have been lodged in respect of the Lyme Green Settlement application. I spent some time today with the owner of the Rayswood Nature Reserve. He is very concerned as the issues involving drainage onto his land and the risk of trespassers as he tells me that the council are unwilling to entertain the construction of a solid fence between the new development and his land.

I will await any additional comments which Councillors may consider should be made in respect of the application.

At the last meeting, I mentioned that the Settlement had invited me to a meeting but then subsequently cancelled it. I have not heard further on whether the Trustees intend to set a new date for the meeting.

I note that a fresh application to convert the Sutton Gamekeeper pub to two houses has been lodged. I would welcome any thoughts from Councillors on this application. My view is that while in one sense, nothing has changed since the previous application was made, it does occur to me that we are now some years on, and the property has just sat there empty. Given the current economic outlook, it may be unlikely that a commercial operator will take on the pub and therefore should the previous objections be revisited?

I also note that revised plans have been submitted for the Hawkshead Quarry. I remain supportive of the application and will await to see if councillors have any additional comments on this application.

Please let me know if there are any matters which Councillors wish to raise with me.

Appendix 5 - report from Park 4all @Lyme Green. September

We have almost finished the installation of the carved log bird feeder in Lyme Green park - just one final bit to complete and that is the metal insert for the water bowl part of the sculpture. It looks fabulous and I can see the birds are using it as the fat balls and seed are definitely going down!

There are also a couple of equipment installations that are to be installed but this is taking a little time from Ansa.

Christmas Event - This year we will be holding our Christmas event around the tree on Robin Lane/junction of Stanier Close on Friday the 16th December 2022. We are currently working on arrangements for this, as you know it was a huge success last year which included local vocalist Gemma Sutton, a brass band, refreshments and a visit from Santa, we are sure it will be a success once again.

In 2021 your members kindly donated £50 towards the music and £38 for the printing of the flyers, your members did raise the question of 'Would the printing be necessary in future years'. We do think it will be and intend to distribute flyers to every household to advise of the date. We consider this to be very important to help with the fact that a large number of the community in Lyme Green are digitally excluded. The NHS national strategy has identified that sections of the population where people are more likely to be digitally excluded than others, the community of Lyme Green ticks a number of these boxes, such as older people, low income groups, people in social housing and people with disabilities.

The music which will again include Gemma Sutton and 'The Voice Box' and we have ascertained that the printing costs this year will be £40 for the 310 A5 flyers and two A4 laminated copies.

We kindly ask that your members consider a donation of £50 towards the music together with either the full printing costs of £40 or something towards this figure.
