MINUTES OF THE PARISH COUNCIL MEETING

- 174/23 THE COUNCIL RESOLVED to receive and accept apologies for absence from Councillors M Bhatia, B Griffiths and M Horrox.
- 175/23 THE COUNCIL RESOLVED to receive Dispensations and Declarations of Interest: Cllr Stepien-Bialy declared an interest in Item 189/23 (as Editor of the Grapevine).
- 176/23 THE COUNCIL RESOLVED to agree and sign the Minutes as a true record of the meeting dated 8th June 2023
- 177/23 Public Participation THE COUNCIL RESOLVED to receive information/queries/questions from MOPs regarding:
 - MOP spoke asking that Members consider providing a character reference as set out in Item 188/23.

MEMBERS REPORTS

- 178/23 THE COUNCIL RESOLVED to receive report from the Cheshire East Ward Member. See Appendix 1 Members also discussed why Highways insist on not implementing a 30 mph on the main road. The Ward Council informed Members that he would wait for some of the houses to became occupied (on the Gaw End site) before putting in a request to re-look at implementing 30 mph.
- 179/23 THE COUNCIL RESOLVED to receive report from Macclesfield Neighbourhood Policing Team (See Appendix 2)
 - PC Jackson sent his apologies. It was noted that the main issues reported at police surgeries were, inconsiderate parking, speeding and parking around the Kings Head public house.
- **180/23 THE COUNCIL RESOLVED** to **receive** report of the Climate Emergency Working Group and **agree** to support a Childrens day (8th October) and to chase Cheshire East for clarification regarding the development the land for an Orchard.
 - The group met on 12/6 with the primary conversation covering the disappointing turnout for the Earth Day. It was felt this had a lot to do with publicity. It was reported that the Curate is setting up an ECO Group at the Church and it made sense to have one overarching group involving them. It was suggested holding another children's day on 8th October but, co-ordinating with the Church. Members were asked if they would support a secular event about climate change and promoting best behaviour (a replay of some of the activities from the Earth Day). This was agreed.
 - Proposal for Community Orchard (in conjunction with Macclesfield Wild Network) it has become clear that a resident also has a potential interest in the land for grazing and has asked about exploring a joint proposal with the Community Orchard centre stage. The group would prefer to know what Cheshire Easts position is regarding the land as there are no current grazing license. The Ward Councillor felt that the Group could go forward based on correspondence he has received however, Members agreed they need a formal response from Cheshire East. ANSA are assessing the suitability of proposal. It was reported that grazing licenses are usually over the summer and possibly extending for a year. Members of the group said that they need to know the position to be able to start with community engagement. It was noted that a planning application could be put in however, would cost the Council.

181/23 THE COUNCIL RESOLVED to **receive** report from graveyard working group and **noted** that the group had no further updates from the June Meeting.

HIGHWAYS MATTERS

182/23 THE COUNCIL RESOLVED to receive reports on highways issues and agree the following actions:

- White lines need re-painting at bottom of Jarman where it joins Hall Lane (urgent as lines have disappeared).
- Grids requested all grids need emptying in the parish. Informed members need to to submit specific drains. Particularly Parvey Lane and Leek Old Road pictures needed.
- Leek Old Road Ward Councillor has submitted a lot for this road and Highways slowly getting through them.

ALLOTMENTS

183/23 THE COUNCIL RESOLVED to **receive** report on allotments: Reported inspection held on 12th July. Plot 13 still unworked with lots of carpet put down. Third stage letter to be sent asking tenant to vacate the plot and remove all carpet. Reported plots 4B, 5A and 5B are not being cultivated. Paths and the beds need weeding. 1st stage letters to be sent out to these tenants.

It was noted that there is a mistake on the timetable in Langley which says the bus from Brighton Crescent and not Langley Methodist Church.

Appendix 1 – Ward Councillors report

- Contacted Planning Enforcement regarding complaints of dust on Gaw End Lane advised Enforcement have visited twice and have not found any problems. No further action to be taken by Enforcement. However, the Ward Councillor disagrees with the outcome.
- CEC are about to sign a Section 278 agreement for works to take place on London Road. Appears the works include removing large tree on junction. He has asked them not to remove tree and will request a TPO to be taken out on the tree.
- Full Council meeting will be held next week, and he will be proposing a motion for a hydrogeology assessment to be submitted to local planning authority regarding Dans Moss.
- He will also have questions regarding changes to the bus service and speak with transport.
- Council Members are asking to increase their allowances. Despite freezing Councillors allowances at the last budget meeting. He will not be supporting this. Budget is already precarious.
