- 274/23 THE COUNCIL RESOLVED to approve bank reconciliation up to 31st October and verify figures against bank statements.
- 275/23 THE COUNCIL RESOLVED to review draft budget/precept for 2024/25 and to make amendments including showing 4% increase in precept, include element for notice boards, check lighting costs, salary, and to separate out defibrillators as an element on its own. Members wondered what the effect of the new housing would have on the precept.

HIGHWAYS MATTERS

276/23 THE COUNCIL RESOLVED to receive reports on highways issues and agree the following actions:

- Two potholes, Sutton side of aqueduct, filled in but have already sunk. To complain about workmanship.
- Plough House tree is taking over footpath to issue letter to resident.
- Lyme Green at the crossing point on Lindrum Avenue there is a raised ridge on the pathway which could be tripping issue.
- Langley the pavement from opposite Lavender Fields entrance to Langley Institute is disintegrating. The kerb is coming away in places and a utility repair running the length is becoming uneven.
- Langley Kerb by the lamp post (number missing) opposite the Langley end of Hall Terrace/Gas House which is collapsing into the road causing a pothole in the pavement.
- Clarke Lane past Bottoms Reservoir on right hand side just before treatment works car has gone into wall. Wall in dangerous condition.
- Langley Road bulb gone on Langley Road (third lamp on left on bend).
- Sutton light outside St James House still not working.
- To report to PCSO traffic issues from Chapel through the village (usually when not raining and on Sunday).
- Langley dog dirt on pathways is a particular issue at the moment.

MATTERS FOR CONSIDERATION BY THE COUNCIL

277/23 THE COUNCIL RESOLVED to agree to install notice boards at the following sites:

Allotments – small aluminium notice board allotments. (Either options 4.1.2 (not magnetic) to request pictures for option 4.2.2 if available.

Rural Ward – Rural Councillors to investigate where best to place notice board.

Lyme Green – agreed in principle and for Lyme Green Councillors to investigate best position for notice board potentially at Lyme Green Park. (4 Councillors in favour 5 abstained).

278/23 THE COUNCIL RESOLVED to agree the following response to Cheshire East Council – Maintenance of green spaces consultation Public Consultation (deadline 24th November):

Typology/Zones

Typology "C" - Cop Meadow, Lyme Green and Langley playing fields.

Amenity Level "M" - Cop Meadow, Lyme Green and Langley playing fields.

Typology "E" - Rural open spaces - all grass verges through parish.

The proposals have a large number of expressions such as "where appropriate" and "subject to prioritisation." The document should avoid such subjective statements and instead state minimum standards, which can always be exceeded, and to which the local authority can be held to account. Not a "maximum" figure with no stated minimum. E.g. Urban Green Spaces – Boarders/planted areas "Ad hoc as required – maximum of 8 visits annually" Rural Open Space – Hedges "Ad hoc as required subject to prioritisation of resource availability."

There is no specific mention of Green Space user's safety needing to be a priority in establishing the level of maintenance required in an area. Keeping creating safe spaces for people to enjoy. E.g. Walking through a park at dusk surrounded by large borders with overgrown shrubs can be very unsettling in case someone is hiding in them.

The borders and verges, which are planted with spring bulbs, should not be cut until after they have flowered. In our parish we also have some areas that have been planted with spring bulbs and English bluebells by our residents and verges and banks where wild bluebells growing. These areas should not be cut until the end of May (the banks on Judy Lane, Sutton and Coalpit Lane in Langley. The track leading through from Cop Meadow to the Children's Play area & playing field has also been planted with snowdrops and bluebells by volunteers).

Appendix 1 - Ward Councillors report

Finances

Some of you will have seen that the Council's financial position has further deteriorated, with a current position of an overspend of around £18m against reserves of around £14m. Rising costs of both adults and children's social care are the two primary reasons given for this, but it is also the case that the Council has not implemented many of the savings it identified for this financial year when the budget was set in February. The Corporate Policy Committee last month delegated a number of budget decisions to officers, and we will be seeing more consultations coming forward to increase fees and charges. The next few months are going to be difficult.

Gaw End Lane

I have yet to have a response to my enquiries about the new island for the uncontrolled crossing, about the s106 monies for Lyme Green Park, or my request for the variation of condition application (about the controlled pedestrian crossing being in place before any houses are occupied). Chasing each of these.

Langley playing fields

I have submitted an enquiry about the s106 monies from Lavender Fields for the Langley playing fields, as the first payment should have been made when works started. You may know that the Council's internal audit team recently gave a 'no assurance' finding in relation to the Council's management of s106, which is the lowest audit rating possible. I understand that several millions have been collected but not allocated to individual schemes, and suspect this includes the playing fields. I will let you know what happens.

Traffic calming

I have been contacted by a resident concerning traffic calming, especially along Walker Lane but also on other roads across the three villages. I think this resident has contacted the parish council directly and happy to discuss.

14 bus

I understand that Cheshire East has been allocated additional funds for bus routes by the Government, and am trying to find out how these monies will be spent and whether there is any room for further subsidy for the 14 bus.
